A LAW TO AMEND THE MONETARY AUTHORITY LAW (2020 REVISION) TO ADD THE PRIVATE FUNDS LAW, 2020 TO THE LIST OF REGULATORY LAWS; TO UPDATE THE LIST OF PRIVATE SECTOR ASSOCIATIONS THAT THE CAYMAN ISLANDS MONETARY AUTHORITY MUST CONSULT UNDER SECTION 4 OF THE MONETARY AUTHORITY LAW (2020 REVISION); AND FOR INCIDENTAL AND CONNECTED PURPOSES

ENACTED by the Legislature of the Cayman Islands.

Short title

1. This Law may be cited as the Monetary Authority (Amendment) Law, 2020.

Amendment of section 2 of the Monetary Authority Law (2020 Revision) - definitions

- **2.** The *Monetary Authority Law (2020 Revision)* is amended in section 2, in the definition of the words "**regulatory laws**" as follows
 - (a) in paragraph (ga), by deleting the word "and" where it appears at the end of that paragraph;
 - (b) in paragraph (h), by deleting the comma and substituting the word "; and": and
 - (c) by inserting after paragraph (h), the following paragraph —

"(i) Private Funds Law, 2020,".
