## **NOTICE**

### **RE: Financial Sanctions Notice**

The Cayman Islands Monetary Authority ("CIMA") hereby notifies you that it has received a new Notice from the Office of Financial Sanctions Implementation, HM Treasury ("OFSI"), which is attached as an Annex to this Notice.

## 1. What you must do:

- A. In the case of an addition or amendment of a person to the <u>Consolidated List</u> and asset freeze:
  - i. Check whether you maintain any accounts or hold any funds or economicresources for the persons set out in the OFSI Notice;
  - ii. Freeze any such accounts and other funds or economic resources.
  - iii. Refrain from dealing with the funds or assets or making them available(directly or indirectly) to such persons unless licensed by the Governor.
  - iv. Report any findings to the Financial Reporting Authority ("FRA") at <a href="mailto:financialsanctions@gov.ky">financialsanctions@gov.ky</a> together with any additional information thatwould facilitate compliance with the relevant legislative requirements.
  - v. Provide any information concerning the frozen assets of designated personsto the FRA at <a href="mailto:financialsanctions@gov.ky">financialsanctions@gov.ky</a> and submitting a compliance reporting form. Information reported to FRA may be passed to other regulatory authorities or law enforcement.
- B. In the case of the removal of a person from the <u>Consolidated List</u> and unfreezing ofassets
  - i. Check whether you have frozen assets of any person or entity removed from the Consolidated List and verify that the person is no longer subject to an asset freeze.
  - ii. Remove the person from your institution's list of persons or entities subject to financial sanction.
  - iii. Un-freeze the assets of the person and where necessary re-activate all relevant accounts.

- iv. Send advice to the person that the assets are no longer subject to an assetfreeze.
- v. Advise the FRA at <a href="mailto:financialsanctions@gov.ky">financialsanctions@gov.ky</a> of the actions taken.

Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.
